


APPENDIX E

**Side Agreement between the University of California
And AFSCME Local 3299**

Employees in the title codes in the departments at UCSF Medical Center specified on the attached list will be eligible for the following:


1. An employee who is called back to work while in on-call status and required to return to the workplace, shall be paid a minimum of three (3) hours or for hours worked, whichever is greater, at the rate of time and one-half (1 1/2 X) the employee's regular rate of pay.
2. Minimum periods shall not overlap. If an employee returns to the workplace from on-call status any subsequent times during a minimum period, no minimum hours will apply for that return and the employee will be paid for hours worked during that return at the rate of time and one-half (1 1/2 X) the employee's regular rate of pay.

The employees who this agreement applies to will be eligible for the above pay benefits effective March 15, 2004. This agreement replaces any previous local agreements between UCSF and AFSCME, Local 3299 regarding on-call and call back pay.



