The University formally confirms receipt of your May 1, 2023 request to seek modifications to the Collective Bargaining Agreement (CBA). In accordance with Article 8.B. Duration of Agreement of the current CBA between the University of California Santa Cruz and American Federation of State, County and Municipal Employees (AFSCME), Local 3299, Skilled Crafts Unit (K7), the University is notifying the AFSCME 3299 of its intent to negotiate a successor Agreement. The University plans to present proposals consistent with the Public Notice requirements of HEERA.
