The University of California's Postdoctoral Scholars Benefits Plan (PSBP) includes comprehensive medical benefits that encompass the broad needs of our diverse workforce to keep postdoctoral scholars and their family members healthy. Included are transgender health benefits as highlighted in this fact sheet.

## WHAT UC HEALTH BENEFITS COVER

UC's health plans cover a wide range of transgender health benefits; however, there are some variations between plans. Check your medical plan's Evidence of Coverage booklet or call the carrier directly for additional details, including requirements for prior authorization and applicable co-pays and deductibles.

### UC MEDICAL PLAN COVERAGE TYPICALLY COVERS

- Prescription drugs

### **UC BEHAVIORAL HEALTH PLAN COVERAGE TYPICALLY COVERS**

- Psychological counseling
- Pre-transgender surgery clinical assessment

Managed Health Network (MHN) administers the behavioral health benefits for the Health Net HMO and PPO plans.

In certain situations, travel expenses to a surgical facility may also be covered. These benefits could include reimbursement for airfare, hotel stays and meals. These expenses should be discussed with the plan during the preauthorization process.

### MORE ABOUT TRANSGENDER HEALTH BENEFITS

Generally, UC's medical plan transgender health benefits are based on medical necessity and guidelines (Standards of Care 7th Version) provided by the World Professional Association for Transgender Health (WPATH).

After transgender procedures are completed, human resources and benefits records should be updated; contact the UCPath or local benefits office for help.

All services require preauthorization and/or may require members to follow plan guidelines in obtaining services to ensure services are covered.
