The Board presently declines to pursue an injunction as requested by Regents of the University of California (UC), as UC has not established that injunctive relief is "just and proper" under the standard set forth in *Public Employment Relations Board v. Modesto City Schools District* (1982) 136 Cal.App.3d 881. The Board, however, shall leave open UC's request in the event it learns of evidence or facts to support a finding that injunctive relief is just and proper.

Because this matter remains open, UC is not required to renew its 24-hour notice under PERB Regulation 32450, subdivision (c), before filing additional evidence. UAW shall have an opportunity to respond to any new filings by UC.
